I would like to discuss this at our November meeting: Dr. Andy Moore reached out to me shortly after the passing of Fr. Norman. He suggested CEOF consider a scholarship in Fr. Norman's memory. However, I would like to discuss with you the possibility of an annual award in his name that goes to an LC student (selected by their faculty) who embodies the spirit of servant leadership. I think a \$1,000 monetary award should be given to the recipient. This will be funded annually by a donor. Your thoughts?

Lexington Catholic has created three scholarships and an award in Fr. Norm's memory.

The Fischer Scholars: Making Education Accessible Fund. This is a tuition assistance program for current students.

The Joyful Knight Award: Honoring a Life of Joy and Kindness - In memory of Fr. Norman this award celebrates a current LC student who embodies his spirit. Students in grades 9-11 are invited to submit an essay illustrating how they spread love and kindness. It will serve as a tribute to Fr. Norman's lasting impact on the lives he touched and will be awarded at the Spring Awards Ceremony.

The Father Norman Fischer Vocation Scholarship: It's a scholarship to foster the next generation of spiritual leaders who share Fr. Norman's calling.
